COLLEGE SCHOLARSHIPS: SCHOLARS MUST BE ATTENDING AN ACCREDITED COLLEGE, UNIVERSITY OR TRADE SCHOOL IN THE UNITED STATES. SCHOLARS MUST BE A SURVIVOR OF CANCER AND HAVE A HOUSEHOLD INCOME OF \$150,000 OR LESS. A SURVIVOR IS DETERMINED AS SOMEONE WHO HAS BEEN DIAGNOSED EITHER CURRENTLY OR PREVIOUSLY WITH CANCER.
